We are so exciting that you are interested in joining us as a vendor at the Cottage Market at Forth!

We will be in touch with you EITHER way (if you are accepted as a vendor or if we are full up).

Prompt payment of Vendor Fees will ensure you are guaranteed a table in the market. We will not hold a spot without payment for more than 24 hours and absolutely not hold it past the payment cut off dates (10 business days prior to each market). Do not issue payment until after you have been offered a table by the organizer.

Table coverings will not be provided by the market organizers. Please bring your own table coverings.

We have a limited amount of vendor spaces available. We have 15 tables available until May 29th and following that we will have 30 – 32 spots up for grabs. Set up will be on a first come, first serve basis. Of the 15 tables available five are in the basement level next to the Pinball gallery. This area is clearly visible from the back of the main floor and we will be posting signage to direct shoppers down to the gallery and to the vendors situated on that secondary floor.

Registration payment

Registration fee must be sent via e-transfer to Bluestone Cottage at cottagemarketwinnipeg@gmail.com at least 10 business days prior to the market. We need our vendors confirmed 10 business days prior to the market in order to satisfy the demands of the Health Inspector. Thank you for your understanding. Once your application has been reviewed we will contact you to offer you a table space (or if we are fully we will let you know that as well). Once you have been offered space please promptly submit your registration fee.

Load In information

Load in must occur from the loading dock and/or back door. The loading dock is unfortunately not at ground level. Organizers will be on site to assist as much as possible. Load in can start after 9am. Vendors MAY NOT load in through the café front doors.

Set up Times

Load in can begin after 9 am. Vendors must leave their displays set up until 3:15pm unless they have been given specific allowance to tear down early by the on-site organizer.
